### Bimini

930/101- Est 9410 for \$595 is COMPLETE- sod was installed where stump was ground.

Est 9492 for \$125 to remove palm was approved on 6.20.16 and is awaiting tree service.

Est 9580 for \$89 to fill in bushes near area tree was removed is APPROVED.

873/101- Est 9435 for \$85 to remove ferns is currently IN WORK.

### Cayman

644ms- Est 9464 for \$150 to replace sod is COMPLETE.

729ms- Est 9451 for \$54 to cut overhanging palm fronds will be COMPLETED tomorrow.

717ms- Warranty replacement of a dead shrub near the front door will be COMPLETED tomorrow.

639ms- Warranty replacement of dead sod due to chinch bugs is approved and awaiting quality sod.

### Martinique

### Common Area

785cbc- Est 9433 for \$315 will be COMPLETED this week once quality sod is available.

Est 95041 for \$3030 was APPROVED to enhance the area around the front entrance pond, and will be completed once quality sod is available.

### **New Business:**

Palm Trimming- Mike Wentworth recommends that we schedule trimming of all palm trees throughout Tarpon Cove, except for coconut palms, as they were trimmed in the spring. An estimate was given for \$7620 to trim all 689 Sabal palms, and \$2700 for all other (non-coconut) palms, totaling \$10,320. Chairman DeSiato made a motion to approved trimming of all non-coconut palms for \$10,320, Director Greenleaf seconded, and the motion passed unanimously. The work will be begin within 30 days once Leo Jr's tree service is available.

Irrigation: A brief discussion was had regarding the irrigation system in Tarpon Cove. The system is currently not capable of properly irrigating all zones during the short 11p-5a window of adequate water pressure supplied by Collier County. Mike Wentworth will review the irrigation blueprints for the community and may have options for us to discuss as early as our next meeting. Facade
