Barbados at Tarpon Cove Drive

730/203- Estimate 9701 was APPROVED for \$740 to remove a dead palm tree at this address, along with 3 others at 792 Carrick bend circle.

Barbados at Carrick Bend Circle

792- Estimate 9701 was APPROVED for \$740 to remove 3 dead palm trees at this address, along with one at 730 Tarpon Cove Drive.

Bimini

930/101- Est 9492 for \$125 to remove palm was approved on 6.20.16 and is awaiting tree service.

Est 9580 for \$89 to fill in bushes near area tree was COMPLETED..

873/101- Est 9435 for \$85 to remove ferns is COMPLETE.

Cayman

639ms- Warranty replacement of dead sod due to chinch bugs is approved and awaiting quality sod.

656ms- Sod will be replaced where irrigation was repaired at NO COST.

742ms- Est 9581 for \$150 to remove dead palm tree was APPROVED. Awaiting tree service.

676ms- Flowering plant is healthy. Dead sod will be replaced under WARRANTY due to chinch bugs.

661ms- Request was DENIED as tree was removed under the condition that roots would remain and no replacement would go in its place.

741ms- Estimate 9700 for \$245 to remove overhanging palm is APPROVED. Will be done w/ palm trimming.

Martinique

Sod was replaced under WARRANTY at buildings 1005 and 1025.

Missing sod where ornamental tree was removed was replaced at NO COST.

Common Area

Est 95041 for \$3030 was COMPLETED to enhance the area around the front entrance pond.

Director Greenleaf has asked that Leo Jr trim the sea grapes along Tarpon Cove drive between Martinique and Bimini, as they should be trimmed quarterly.

Director Greenleaf has also noted that the grass between the Barbados pool and Mainsail pond needs attention, as it's beginning to die.

New Business:

<u>Palm Trimming</u>- As coconut palms have begun to produce fruit, estimate 9699 for \$7400 was presented to the committee. Leo Jr noted that this price will increase as the fruit size increases. Director Fremeau made a motion to approve estimate 9699 for \$7400, Director Soucek seconded, and the motion passed unanimously. This work will be done with the already scheduled palm trimming project. As palm trimming will already run over budget for the year, this will be paid from the contingency budget.
