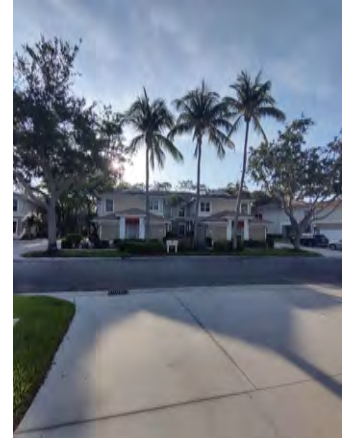

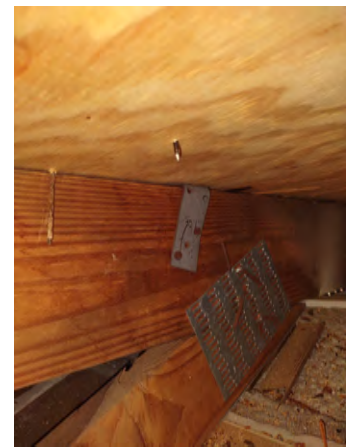

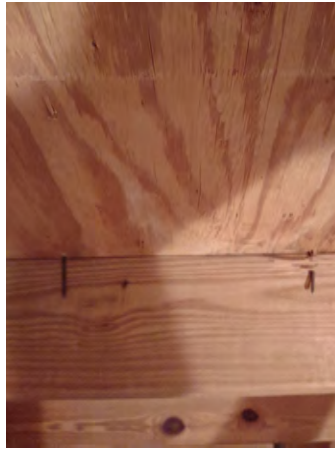

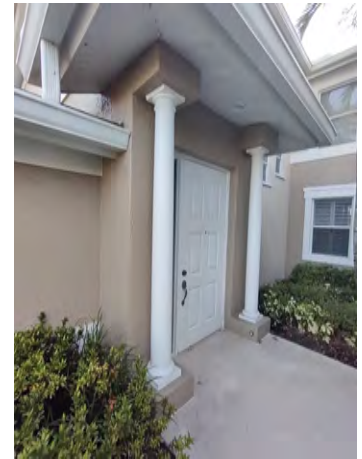

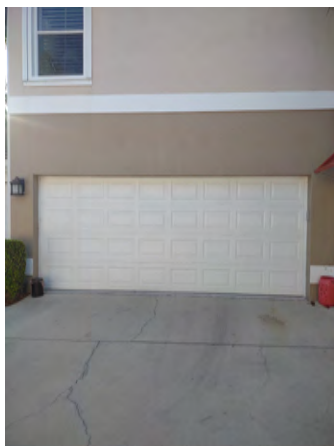
**Roof Deck Thickness**
