1. Call to Order

2. Establish a Quorum

Quorum was established with 108 members in person or by proxy. 73 Were needed for a quorum.

Proof of Notice of Meeting

Proof of notice was confirmed according to FL statutes and association's documents.

4. Reading or waiver of Reading of Last Annual Meeting Minutes

The reading of the past annual meeting minutes was waived. The Minutes were approved.

5. Announcement of 2025 Board of Directors

Rick Forrester - Term expiring in 2026 Donna Scuteri - Term expiring in 2026 Don Binder – Term expiring in 2027 Charles Ingle – Term expiring 2026 Tim Wry – Term expiring 2027

- 6. **President's Report:** President Forrester gave his president's report with the following highlights:
 - As of the meeting, we have \$42,550 in unused hurricane assessment funds, which will all be allocated towards new plantings, tree trimming, asphalt repairs, and pool repairs.
 - The golf course driving range is open. When it was first proposed, Tarpon Cove asked that a screen not be installed on the driving range, however, we've had multiple balls come across the canal to the villas and we've now asked that a net be installed until the tree buffer fills in.
 - A new fire station will be built near the Martinique circle, with an emergency fire exit for Tarpon Cove residents also being installed at the same time. The fire exit gate will remain locked and the fire department will control access at the new exit.
 - Resident Fred Neri spoke on the petition to have the county or Benderson Development install a sidewalk between the plaza and Tarpon Cove, as residents currently have to cross the road twice to walk or cycle to the shopping center.
- 7. **Treasurer's Report:** Director Binder gave a financial report on the 2024 fiscal year. He noted that while we finished 2024 with a slight surplus, we are still in negative equity and will need to keep spending

to a minimum in 2025 until we're out of the negative. The tree and landscaping work done after hurricane Milton should help reduce our normal landscaping expenses in those areas throughout the year, which will help generate a surplus in 2025.

8. New Business

- Roll Over of Excess Funds... It was unanimously approved by all members present in person and by proxy to rollover excess association funds to next year's budget (if any). (107-1)
- Waiver of the 2025 financial auditing requirements is not permitted. The 2025 Fiscal year will be audited/reviewed by cpa in 2026.
- 9. **Resident Comment Period.** All questions were answered accordingly by the board.
